Inhalation:

Short term exposure: Available data indicates that this product is very corrosive to the respiratory tract. Symptoms will include extreme pain in nose, throat and lungs, and copious secretion of mucous in the nose and throat. Other symptoms such as pulmonary oedema are also likely, and may be life threatening even following brief exposure. **Long Term exposure:** No data for health effects associated with long term inhalation.

Skin Contact:

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Evacuate the spill area and deny entry to unnecessary and unprotected personnel. Wear full protective chemically resistant clothing including eye/face protection, gauntlets and self contained breathing apparatus.
